

**NOTICE OF ANNUAL FIRE DISTRICT ELECTION

NOTICE IS HEREBY GIVEN to the legal voters of Fire District No. 2, in the Township of Moorestown, County of Burlington, State of New Jersey, that the Annual Meeting and Election for the legal voters of said Fire District will be held on Saturday, FEBRUARY 21, 2015 beginning at 2:00 PM in the afternoon at the Lenola Fire House located at 229 N. Lenola Road in the Township of Moorestown, for the purpose of electing two individuals to membership for a three year term on the Board of Fire Commissioners of said District and to determine the amount of money to be appropriated and raised for Fire District purposes in the Fire District for the ensuing year.

The 2015 Budget for the Fire District, which was adopted by the Board of Fire Commissioners of said Fire District at a regular meeting held on January 7, 2015 after all persons interested were given an opportunity to be heard, is as follows:

NOTICE IS HEREBY FURTHER GIVEN That pursuant to the resolutions adopted by the Board of Fire Commissioners of the Fire District on January 7, 2015, the following propositions will be submitted to the legal voters for approval or disapproval:

Shall the Board of Fire Commissioners of Fire District No. 2 in the Township of Moorestown be authorized to repave the front and side parking lots of the Lenola Volunteer Fire Station for a cost not to exceed Ninety Thousand Dollars (\$90,000.00)? Funding will be provided from unrestricted reserve fund balance.

Shall the Board of Fire Commissioners of Fire District No. 2 in the Township of Moorestown be authorized to purchase a replacement command vehicle for the Fire Chief at a cost not to exceed Sixty Thousand Dollars (\$60,000.00)? Funding will be provided from unrestricted reserve fund balance.

The polls of said election will be open between the hours of 2:00 PM and 9:00 PM or as long thereafter as the Board may designate as necessary to poll the vote of the District.
