NOTICE IS HEREBY GIVEN to the legal voters of Fire District No. 2, in the Township of Moorestown, County of Burlington, State of New Jersey, that the Annual Meeting and Election for the legal voters of said Fire District will be held on Saturday, FEBRUARY 16, 2013 beginning at 2:00 PM in the afternoon at the Lenola Fire House located at 229 N. Lenola Road in the Township of Moorestown, for the purpose of electing two individuals to membership for a three year term on the Board of Fire Commissioners of said District and to determine the amount of money to be appropriated and raised for Fire District purposes in the Fire District for the ensuing year.

NOTICE IS HEREBY FURTHER GIVEN That pursuant to the resolutions adopted by the Board of Fire Commissioners of the Fire District on January 2, 2013, the following propositions will be submitted to the legal voters for approval or disapproval:

Shall the Board of Commissioners of Moorestown Fire District No. 2 be authorized during the 2014 fiscal year to repave the parking lot of the Lenola Fire Station for a cost not to exceed Seventy Thousand Dollars (\$70,000.00)? Funding will be provided from unrestricted reserve fund balance.

Shall the Board of Commissioners of Moorestown Fire District No. 2 be authorized during the 2014 fiscal year to purchase a replacement vehicle for the Fire Official at a cost not to exceed Thirty Eight Thousand Dollars (\$38,000.00)? Funding will be provided from unrestricted reserve fund balance.

The polls of said election will be open between the hours of 2:00 PM and 9:00 PM or as long thereafter as the Board may designate as necessary to poll the vote of the District.
